Family Camp Rules

1. This is a Christian camp, and all conduct should that which is becoming of the Gospel of Christ.

2. No drugs, alcohol. Tobacco, firearms, or fireworks are permitted to be on the campgrounds.

3. Modest and appropriate clothing must be worn at all times:

- All shorts and skirts must be no shorter than 2' above the knee.
- No revealing tops are to be worn at camp. Campers and sponsors: shoulders, midriff and cleavage must be covered, or another shirt worn underneath. This means no tank tops, sleeveless shirts, or spaghetti strap dresses.
- No inappropriate messaging will be allowed on any clothing.
- If you are serving on the stage, boys must have collared shirts and long pants and girls must wear dresses or long pants.
- Pajama pants are not to be worn outside of the cabins.
- Campers and sponsors must be covered coming to and from the pool.

4. Electronic devices may only be used for Bible reading or note taking. Cell phone use should be limited.

5. Prank activities that deface camp or personal property are forbidden.

6. All campers are to always remain on campus. Campers are expected to attend all classes, services, and activities **UNLESS** they are under the care of the camp nurse.

7. All prescription medications must be kept with the camp nurse.

8. Campers are not allowed in a cabin without a sponsor.

9. Boys are not allowed around the girl's cabins and girls are not allowed around the boy's cabins...FOR ANY REASON.

10. Any sponsor or camper disregarding these rules may be discharged from the camp.

11. No person 18 years of age and older be allowed to stay overnight or enter any dormitory without providing verification of a cleared background check. do not fear Isaiah 41:10

Fees, Registration, and Notes

This year's camp fee is **\$155** and is due upon arrival at camp. Part time campers will be \$45 per day. We prefer that all churches pay with one check and make all checks payable to **BSFC**. Camp fee covers room and board and meals. Fees **DO NOT** include money for meals on the way to camp, snacks at camp, or items for sale at camp.

Pre-registration is due by **June 15, 2024**. Please call, text, or email Jason Hebert at **318-344-3061**, or **boggspringsfc@gmail.com** the total number of males and females (including sponsors) that you plan to bring to camp by this date. Please include your name, church name, **and any accommodations**. Cabins will be preassigned, and I will be as accommodating as possible. Please let us know if you have any handicapped needs associated with your group. There will be **NO** early arrivals unless pre-approved by myself and the Director.

Any campers over the age of 10 can attend camp as long as they are registered with a church. All children **UNDER 10** should be accompanied by a same-sex parent or guardian.

We are continuing the **MANDATORY BACKGROUND CHECKS** for everyone attending church camp this year. Please note the special page in this packet that explains all requirements and deadlines that pertain to this.

PLEASE NOTE: In an effort to be more efficient and organized, **Churches MUST show up together.** The BGC person and payment need to be together and in the first vehicle. Have the sign-up sheet ready and know how many Full-time and Part-time campers you have by the time you arrive.

IMPORTANT!!! BACKGROUND CHECK INFORMATION!!!

Dear Family Camp Pastors and Sponsors,

Please read this letter in its ENTIRETY !!

For the safety of our children, we require a background check to be done on all campers 18 years of age and older. If you plan to be on the campus <u>overnight</u> during our camp you **MUST** have a completed background check beforehand.

We have 3 options for BGCs to be completed:

- 1) ONE point person in your church will need to collect completed forms and forward them to Season Mercer (email or mail) for processing (paid for by BSFC if turned in by May 31st deadline)
- 2) ONE point person in your church will need to collect completed forms and contact Season Mercer to learn how to process the BGCs through the company BSFC is using (paid for by BSFC if processed by May 31 deadline)
- 3) Complete and process BGCs at the company of your church's discretion at your church's expense. With this option, you MUST email proof of BGC completion to Sister Season Mercer by June 15

* The BSFC BGCs go through Shawn Burch with Comprehensive Screening Solutions/People Facts in Bossier City.

Please note, if choosing option 1 or 2 from above, BACKGROUND CHECK FORMS ARE DUE **MAY 31**. These can be turned in one of two ways:

- Scan and email: boggspringsfc@gmail.com (please make the subject: BACKGROUND CHECKFORMS)
- USPS (MUST BE POSTMARKED BY May 31): Season Mercer, 4802 Benton Road, Bossier City, LA 71111

All BGC forms, from option 1 or 2, turned in on time will be paid for by BSFC. All background checks turned in after May 31 will need to be paid for when checking in at camp (\$12.50 per background check).

Again, we ask that everyone be patient with us, as there are bound to be bumps along the way. When you arrive, registration will be the first thing you encounter as you get to the camp. For check-in to run smoothly, please have all full-time (FT) campers from your church arrive at the same time. <u>The BCG point person (as well as whoever handles payment) in the first vehicle. (Please know the number of boys/girls full-time campers as well as boys/girls part-time campers.)</u> When you check in, I will have a sheet with your church name and all names of background checks turned in. This sheet must be signed by the church's BGC point person (again, please ensure this person is in the lead vehicle).

Just a reminder, with BGCs being implemented, we ask that no one come on Sunday unless you have made prior arrangements with Brother Jason Hebert and Sister Season Mercer. Remember, this is for the continued safety of our children.

BOGG SPRINGS FAMILY CAMP Will Obtain a Background Check

You acknowledge and understand that in connection with your volunteer application with BOGG SPRINGS FAMILY CAMP (including any independent contract for services) or when deciding whether to modify or continue your ongoing involvement, we may obtain a "consumer report" and/or an "investigative consumer report" on you from People Facts, a consumer reporting agency, or from any third party, in strict compliance with both state and federal law.

Consumer Report Defined

A consumer report is any communication of information by a consumer reporting agency bearing on your character, general reputation, personal characteristics, or mode of living which is used or expected to be used for purposes of serving as a factor in establishing your current and/or continuing eligibility for involvement. A common term for a consumer report is a "background check report."

Investigative Consumer Report Defined

An investigative consumer report is obtained through personal interviews with individuals who may have knowledge of your character, general reputation, personal characteristics, or mode of living. An investigative consumer report might include, for example, calls to the personal references you provide or conversations with former supervisors or colleagues where you worked.

Reports May Contain

The consumer reports or investigative consumer reports may contain public record information which may be requested or made on you including, but not limited to: criminal records, civil cases in which you have been involved, driving history records, current motor vehicle insurance coverage information, previous employment/volunteer history, social security traces, military records, government records, and others.

You further understand that these reports may include experience information along with reasons for termination of past employment/volunteer. You also acknowledge and understand that information from various federal, state, local and other agencies which contain information about your past activities will be requested.

Your Rights as a Consumer

You are hereby notified that you have the right to make a timely request for a copy of the scope and nature of the above investigative background report and/or a complete copy of your consumer report contained in People Facts's files on you at the time of your request by providing proper identification.

You are further notified that, prior to being denied a volunteer position based in whole or in part on information obtained in the consumer report, you will be provided a copy of the report, the name, address and telephone number of the consumer reporting agency and a description in writing of your rights under the Fair Credit Reporting Act.
